### New LINX BCP v2.0

- http://www.linx.net/www\_public/ community\_involvement/bcp/ubebcp\_v2
- Extra text to cover activities in mutual support of UBE:
  - UBE about hosted Web sites
  - trading in bulk mailing tools and lists
- Requires abuse entries in RIPE DB
- Must not insist on Web submission of abuse reports
- Minor cosmetic changes

### New LINX BCP v2.0

- Minimum modifications for RIPE
- RIPE PDP

- Later:
  - Suggest enhancements?
  - Complete rewrite?
  - Feed back to LINX

#### **Minimum modification**

- Cosmetic changes
- Remove UK-centric items

- Last call (4 weeks)
- Implement (ie publish)



### **C2 Sender authentication SPF**

- Sender Policy Framework
- Purported sender
- . DNS for list of acceptable sources
- Deployment

### **C2 Sender authentication DKIM**

- Domain Keys Identified Mail
- Cryptographically sign part of header
- DNS for public key
- Deployment

#### **C3 Bounce suppression**

- Reject if possible
  - separate MX and delivery systems
- Call-ahead
  - milter-ahead
  - other schemes

- Check before notification
  - retain incoming message
