WHAT IS THE ASO?

- **ICANN's Address Supporting Organization**
- **Formed by the RIR's**
- **The MoU and "Attachment A" are the foundation**
 - **Advises ICANN Board on addressing policy**
 - **Reviews global IP address policy proposals**
 - **Appoints two ICANN BoD Members**

WHAT IS THE ASO ADDRESS COUNCIL?

- **According to ICANN's Bylaws:**
- **Section 2. ADDRESS COUNCIL**
 - **1. The ASO shall have an Address Council, consisting of the members of the NRO Number Council.**

THE UPDATE

- Work on internal processes (Global Policy)
- Submitted to the NRO EC for approval
- Early Awareness of IPV6 Global Policy
- Appointed Sandy George to the ICANN NomCom
- ICANN BoD Appointment Process started, see next slides

NOMINEE ELIGIBILITY

- *Established working group to manage nominations*
- *Secretariat issued announcements*
- *Nominators responded to nominations@aso.icann.org*
- *Chair reviewed and forwarded to ad-hoc working-group*
- *Working-Group compiled data*
 - *Verified accuracy*
 - *Ensured openness, transparency, and full disclosure to AC*
- *Sent up to three requests for response to the nominees*
- *Completed data compilation*
- *Verified, commented, and packaged data*
- *Sent to the full AC with a summary presentation (Thank You!)*

BASIC DEMOGRAPHICS

- 2 nominees declined nomination
 - Damas, and Trautwein
- 9 accepted
 - Wodelet, Palet, Demmink, Ibekwe, Ahmad, Gerboesch, Cernik, Fraser, and Rashir
- 1 was unreachable
 - Farshid Yasoubi
 - We googled, mailed, nominator, etc.
- Nominees accepted from ARIN, RIPE, and AfriNIC regions.

CANDIDATES ACCEPTED

- **Subject to Appointment Procedure:**
 - **Dave Wodelet, ARIN-Region**
 - **Jordi Palet, RIPE-Region**
 - **Uchenna Ibekwe, APNIC-Region**
 - **Envir Fraser, AfriNIC***
 - **withdrew on short notice**

APPOINTMENT PROCEDURE

- **What was or is left?**
 - **Declaring eligibility (done)**
 - **Public Comment period (~30 days, closes by May 3rd, 2006)**
 - **Interviews (conducted in Istanbul on April 25th, both phone and face-to-face)**
 - **Appointment (May 4th 2006)**
