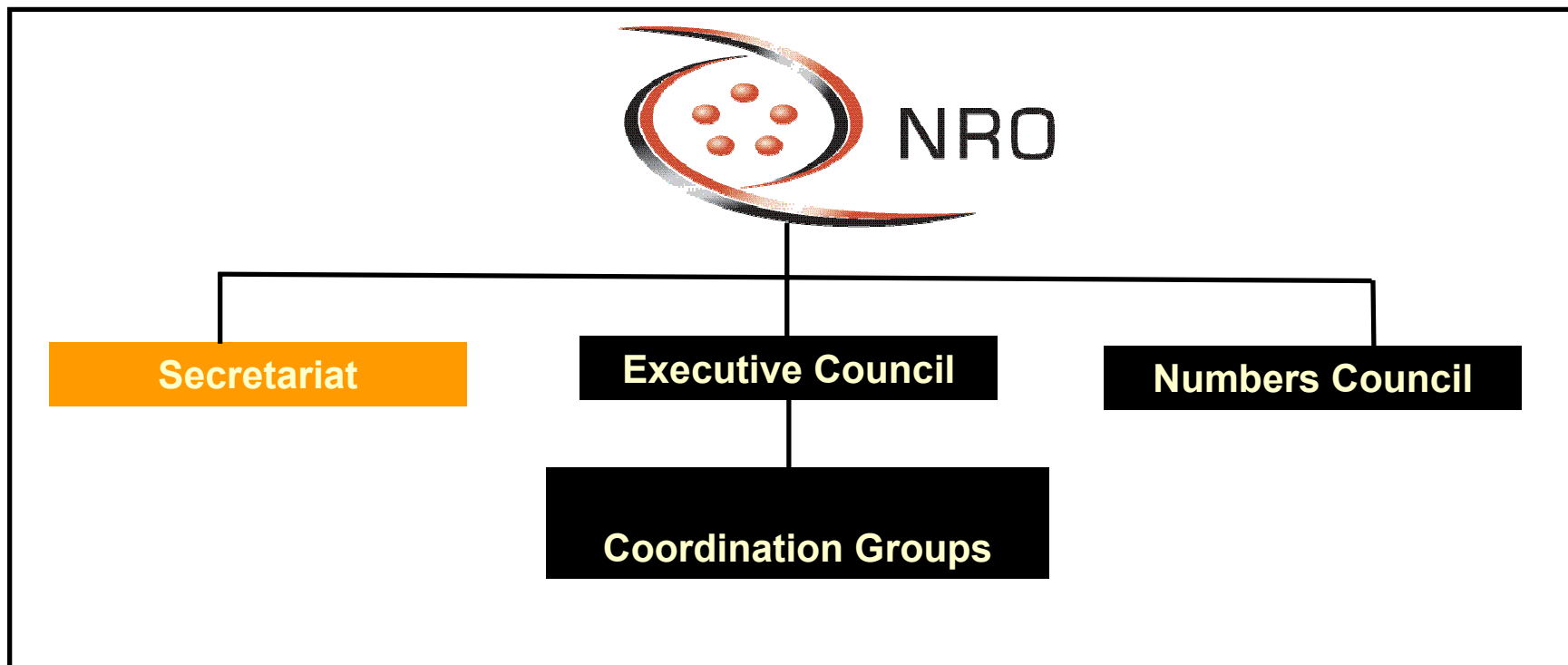
# Number Resource Organization
